

Request for Access to ESB Lab Reports via the Internet Utilizing Promium® Datasystem Software

Terms of Use

The Following Terms and Conditions govern your use of the Promium® Data System Software provided by E. S. BABCOCK & SONS, INC. Access to the System may only be done on the computer who's IP Address you have provided to ESB.

Changes to the System

Termination of Usage

ESB and its Service Providers may discontinue, suspend or modify the System at any time without notice. ESB and its Service Providers may block, terminate or suspend Your (and any user's) access to the System at any time, for any reason, at its sole discretion.
